Pre-event requirements

1. Do not leave this action to the closing day as congestion on our IT site may prevent documents that you must lodge being held up.
2. Prepare your car for competition as per **Scrutineering Reference Sheet** online form available from NSW Supersprint site.
3. Each Driver is required to submit online form *SSP 09 Risk Warning, Disclaimer, Indemnity & Statement of Vehicle Compliance*. Please [Click here](#) to go to NSW Supersprint Web site to complete and submit your online form.
4. Registration papers if your car is road registered and not log booked. You need to email a copy of your registration papers showing you as the owner of the vehicle. If you are not the registered owner you will need to email a completed SSP 19 Legal Vehicle Owners Declaration. Instructions re the email requirements are on the Supersprint Web site.

Documents you need to have with you on the day as printed or electronic format, to refer to.

4. Grid sheet (distributed to entrants 2 days prior to the event)
5. Competition License or evidence of a current competition license (if an official requests to view it)

Arrival at Pheasant Wood Note: Gates will open approximately **7:00am**.

After entering Pheasant Wood

Drive directly to your pit area observing traffic flow signs.

If trailering, unload your car without delay and relocate your tow vehicle and trailer to the park-up area.

Important: Please arrive in plenty of time to prepare your car and yourself before the call up for your first run.

Garages / Carports:

There are limited carports available supplied "free of charge" by **Pheasant Wood**.

Scrutineering

If your vehicle has a Motorsport Australia log book, present your helmet and log book at the scrutineering bay for inspection/updating and collect your scrutineering sticker.

If your vehicle is road-registered and you are a series registrant, you need to present your vehicle and helmet at the scrutineering bay to collect your scrutineering sticker.

If your competition number is 9xx (i.e. you are not a series registrant) and your vehicle does not have a Motorsport Australia Log Book, you need to present yourself and your vehicle as well as your helmet at the scrutineering bay for a visual inspection,

On completion of scrutineering, return to your pit location. Maximum speed in the pit area is 10 Km/h walking pace.

Dummy grid (First run of the day)

After your group is called please be prompt getting to the dummy grid entrance so we can check your car stickers. **Stay in your car.**

Food Van

Please obtain your food and exit the van area in a prompt manner so avoid congestion.

Petrol:

We suggest half tank of fuel per driver. The closest petrol station is at Marulan.

All attendees to this event must abide by the requirements in this document and other documents available for download from the NSW Super Sprint Website. Failure to comply may result in you being reported to the Chief Steward.
